

WARRANTY CERTIFICATE

BITULINE Waterproofing Membrane



MATERIAL WARRANTY

OFIC PHILIPPINES INC. ("ONDULINE"), warrants to the owner of the building described above ("Owner"), that subject to the terms, conditions, and limitations, including the limitations set forth in section 10 below, stated herein, OFIC PHILIPPINES INC. will supply replacement membrane for any defective Bituline Waterproofing Membrane installed according to OFIC PHILIPPINES INC. Technical instructions by a OFIC PHILIPPINES INC. Authorized Waterproofing Applicator for a period of 10 (ten) years.

TERMS, CONDITIONS, LIMITATIONS

1. Owner shall notify OFIC PHILIPPINES INC. on the first business day immediately following the discovery of each leak in the waterproofing membrane and confirm in writing within one week.
2. If on OFIC PHILIPPINES INC. inspection, OFIC PHILIPPINES INC. determines that the leak is caused by a defect in the Waterproofing Membrane except as provided in the following paragraph three (3), Owner's remedies and OFIC PHILIPPINES INC. liability shall be limited to providing replacement material for the defective Waterproofing Membrane.
3. Certificate of Waterproofing Warranty shall be released whenever the application passed waterproofing commissioning test conducted by Authorized Applicator.
4. This warranty does not apply and may be null and void if any of the following occur:
 - (a) The Waterproofing Membrane is damaged by a natural disaster including, but not limited to, earthquake, lightning, hail, wind, hurricane, tornado, or flood, as defined by The National Weather Service, or other acts of God, or;
 - (b) The Waterproofing Membrane is damaged by any act of negligence, accident, or misuse including, but not limited to, vandalism, falling objects, civil disobedience, or act of war, or;

- (c) A deficient pre-existing condition or equipment is causing water entry, or;
 - (d) Metal work or other accessories or equipment is used in the Waterproofing and causes leaks, or;
 - (e) There are any alterations or repairs made on or through the completed Waterproofing Membrane, or objects such as but not limited to fixtures, equipment, or structures are placed on or attached to the completed structure without first obtaining written authorization from OFIC PHILIPPINES INC., or;
 - (f) Failure by the Owner or his lessee to use reasonable care in maintaining the waterproofing system as described in the Owner's Guide provided with this warranty, including that of sealants and caulking, or;
 - (g) Loss of integrity of the building envelope and, or structure including, but not limited to partial or complete loss of decking, wall siding, windows, doors or other envelope components or from damage by wind blown objects, or;
 - (h) Condensation accumulates in the waterproofing assembly, or;
 - (i) A significant change in the use of the building by the Owner or his lessee expected by OFIC PHILIPPINES INC. to effect the Waterproofing Membrane as originally installed, or;
 - (j) The Waterproofing Membrane is damaged by contaminates and/or spills, or;
 - (k) Deficient design or defective workmanship was applied to the Waterproofing Membrane such as membrane contact with incompatible materials and/or failure of membrane seams, or;
 - (l) The Owner fails to comply with every term and condition stated herein.
5. During the period of this warranty, OFIC PHILIPPINES INC., its agents and employees, shall have free access to the building during regular business hours.
 6. Should the Waterproofing Membrane be concealed, the cost of exposure of the Waterproofing Membrane for purposes of OFIC PHILIPPINES INC. investigation and/or repair, such as removal and replacement of any concrete, paving, backfill or overburden, shall be the Owner's responsibility.
 7. OFIC PHILIPPINES INC. shall have no obligation under this warranty until all invoices for materials, installation, and services provided by OFIC PHILIPPINES INC. and the OFIC PHILIPPINES INC. Authorized Applicator have been paid for in full.
 8. OFIC PHILIPPINES INC. failure at any time to enforce any of the terms or conditions stated herein shall not be construed to be a waiver of such provision.
 9. This warranty may be transferred to a subsequent Owner of the Structure if approved in advance and in writing by OFIC PHILIPPINES INC. and the cost to process the transfer and to inspect and repair the OFIC PHILIPPINES INC. Waterproofing System, if necessary, shall be the Owner's responsibility.
 10. The Owner and OFIC PHILIPPINES INC. hereby agree that any and all claims (contractual, statutory, common law or otherwise), disputes, or suits that in any way, directly or indirectly, arise out of or relate to this Warranty, or the alleged breach thereof, or to any contracts between the owner and OFIC PHILIPPINES INC., or the alleged breach thereof, or to the design, manufacture, sale, distribution, installation, and/or inspection of the OFIC PHILIPPINES INC. Waterproofing System, shall first be submitted to non-binding mediation before a neutral mediator jointly selected by the parties or, in the absence of agreement, as designated by the American Arbitration Association. In the absence of resolution by mediation, all such claims shall be settled by arbitration by the American Arbitration Association in accordance with the Construction Industry Arbitration Rules. Any such mediation and/or arbitration shall take place in Boston, Massachusetts. This Warranty, and any claims, disputes or suits between the parties hereto shall be governed by, and construed and enforced in accordance with, the laws of the Commonwealth of Massachusetts.

THIS WARRANTY IS GIVEN IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF. THE REMEDIES STATED HEREIN ARE EXCLUSIVE REMEDIES AND OFIC PHILIPPINES INC. SHALL NOT BE RESPONSIBLE OR LIABLE FOR ANY INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES INCLUDING THE PRESENCE OF MOLDS, FUNGI, BACTERIA, SPORES, MYCOTOXINS OR THE LIKE OR FURTHER LOSS OF ANY KIND WHATSOEVER, INCLUDING BUT NOT LIMITED TO, DAMAGE TO THE STRUCTURE ON WHICH THE COMPONENTS OF THE WATERPROOFING SYSTEM ARE SITUATED, DAMAGE TO THE CONTENTS THEREOF, LOSS OF USE OF THE STRUCTURE OR ANY COMPONENT PART THEREOF, OR DAMAGE TO ANY OTHER PROPERTY OR PERSONS.

NO REPRESENTATIVE OF OFIC PHILIPPINES INC. HAS AUTHORITY TO MAKE ANY REPRESENTATIONS OR PROMISES EXCEPT AS STATED HEREIN.
